Hon. Senators: Hear, hear!

Senator Carney: Honourable senators, I think we should mark this occasion, because it is the first time that the Leader of either the Government or the Opposition has been a woman. This is, therefore, a red-letter day — if I may be excused the pun — in the history of this institution. I hope that it will not be the last occasion on which a woman will hold this position.

I am particularly happy to acknowledge this historic event today because my relationship with Senator Fairbairn goes back about 25 years, to the time when we both first became members of the Press Galley in the 1960s. I am fully aware of the distinguished role that she has played in her many positions in government: as legislative assistant to the former Prime Minister Trudeau, and as a long-time member of the Senate. I hope that she will have the support of all of us in the Senate to enable her to carry out her new and distinguished role.

In my case, she certainly will have not only my support but my affection.

Hon. Joyce Fairbairn (Leader of the Government): Honourable senators, I cannot tell you how delighted I am to hear those words from my friend of many years — and I do believe, Senator Carney, it might even be more than 25.

Senator Gigantès: Not possible — chronologically impossible.

Senator Fairbairn: I will do my very best to be worthy of the confidence and the kindness that you have expressed today. I am also very conscious of the privilege and the honour that has been conferred on me, as indeed anyone would be in this position. It is the biggest challenge of my life. I will work with every bit of dedication, experience and will at my disposal to do a good and credible job for the Parliament of Canada but, most particularly, for all the Canadians we represent in this chamber.
