THE HOUSE OF COMMONS OF CANADA

BILL C-85

An Act to amend the Criminal Code
 (Kidnapping)

Her Majesty, by and with the advice and
 consent of the Senate and House of Com-
 mons of Canada, enacts as follows:

Kidnapping

1. Subsection (1) of section 233 of the
Criminal Code is repealed and the follow-
 ing substituted therefor:

“233. (1) Every one who kidnaps a
 person with intent

(a) to cause him to be confined or im-
 prisoned against his will, 10

(b) to cause him to be unlawfully sent
 or transported out of Canada against
 his will, or

(c) to hold him for ransom or to
 service against his will, 15

is guilty of an indictable offence and is
 liable to the death penalty.”
