Inspector Galpin Would Post Pictures of Inebriates

Speaks of the New Law Passed in Wisconsin—Thinks It Will Work Well.

A measure has recently been introduced at Fond du Lac, Wis., whereby photographs of inebriates, to whom license-holders are forbidden to sell liquor, are posted in the different bars of that city.

The art gallery is not used in London, but a list of incorrigible inebriates, called in bar slang, the "Indian list," is posted in all places where liquor is licensed to be sold.

"How is a man's name first placed on this list?" Inspector Galpin was asked this morning.

Friends interfere.

"Well, it is often put up at the request of friends," he answered. "The magistrate, county judge or an employer can also have the name affixed to the list, and I personally can add such names as I think proper."

"When a man's name is added to this list a registered letter containing the man's name and description is sent to all the local bars, notifying them that they must not sell to this man. Another letter is sent to the drunkard himself, advising him that he has been put on the list, and warning him, however, he insists upon making the attempt, he can be compelled to appear before the magistrate, who has the power either to impose a fine or to send him to jail."

A Stiff Law.

"What happens to the license-holder selling liquor to such a man?" was asked.

Fighting Colored Youth Routs Three Attackers

Sunday Evening Battle Royal Winds Up in Court.

As a result of the recent row which took place on Maitland street on Sunday night last, Wm. Berry, John Duncan and Bert Johnson, colored youths, were this morning assessed \$5 apiece and bound over to keep the peace. Wm. Sloan, who was also implicated in the affair was dismissed.

The whole story of the battle royal, as told this morning by Joseph Seelye, was as follows. Seelye, who hails from Cleveland, and who is at present stopping with his grandfather, the Rev. Mr. Ball, in the grandstand of the city, on the night in question attended the B. M. E. Church on Grey street, accompanied by two young ladies and a gentleman. On the way home from church, the party was accosted by Berry, Duncan and Johnston, who accused Seelye of having insulted a lady friend of theirs in church that night. Before Seelye had a chance to reply the trio attacked him, and bore him to the ground, where they kicked and otherwise maltreated him. Then Seelye's friend got busy and took a hand

in the fracas, only to get a terrific jolt which took all the fight out of him. He disappeared from view, being seen no more that evening.

Eventually Seelye succeeded in getting the better of his opponents, who took to their heels just before the patrol wagon arrived.

Later young Seelye, in company with his grandparent and a friend visited the scene of the scrimmage to search for his hat which had been lost in the heat of battle. Nearby, on a corner, stood the gang which had accosted him. One of the trio made some slighting remark about "relatives" or something to that effect, and in a moment Seelye had picked out the bigger of the crowd and was proceeding to administer a much-needed beating when Mr. Ball intervened, putting a stop to further hostilities. Summons were served on the three youths, and this morning's fines resulted.

"That is not so," he declared today. "All I get is such material as the architect deems unfit for future building purposes, such as broken scutings, damaged laths, etc. Every whole brick and piece of brick must be turned over to the care of the Reid people."

The contractor has from three to five teams and twelve men working on the job now, and anticipates but little trouble in finishing his work on or before they want.

CHICKENS TIED; CRUELTY CHARGED

Two of the Fowl Expire and Humane Society Officer Takes Action.

Henry Gooseberg, a South London Hebrew, appeared before Magistrate Love this morning on a charge of cruelty to chickens preferred by Inspector Sanders.

Gooseberg, it appears, went to the market recently and purchased several bags of potatoes and a dozen chickens. The farmer from whom he purchased the potatoes agreed to deliver the chickens to Gooseberg's house within a short time.

The defendant could not leave his work at the time, so he sent a younger brother out to receive the goods. The boy waited several hours, and when the farmer with the chickens and potatoes did not appear he left the place. Eventually the farmer arrived, and finding no one at home, dumped the potatoes and the chickens at the door, where they lay for five hours before they were discovered. In the meantime two of the fowls had expired.

"Have you got the farmer in court from whom the chickens were purchased?" asked his honor of Mr. Sanders. "I want to know who tied those fowls together."

The inspector admitted that he did not know who the man was, but stated that he could produce the farmer who delivered the goods within a few days.

A market employee testified that it was a common custom for the Jews and Chinese to tie half a dozen or so of chickens together, and then carry them about for several hours until they had completed their marketing.

The case was laid over for one week.

SMASH THE LIGHTS; COMPANY IS ANGRY

G. T. R. Says It Can Do Nothing With Hoodlums at Wortley Road.

Mr. F. J. Coleman, electrical superintendent of the Grand Trunk Railway, has not much respect for the youth of London, and he has written to City Engineer Graydon about the matter. For some time complaints have been made about the lighting of the Wortley road subway, and the company has been blamed considerably for it. Mr. Coleman, in his letter to Mr. Graydon, declares that it is an impossibility to keep the subway lighted. The company would install lights, and the next day they would be smashed. The city police were notified, but nothing was done. The trouble continued, and the company's detectives were unable to stop the depredations. Last Saturday new lights were put in all round, and on Monday morning they were all smashed and the wires cut. Therefore Mr. Coleman declares that it is an impossibility to keep the subway lighted.

Engineer Graydon will likely take the matter up with No. 3 committee. "London has more hoodlums than any city I ever knew," Mr. Coleman declares.

The men decided that the conditions under which they are now working are satisfactory and it would be unfair to the company to go out at this time.

Effner of The Unique. The picture was termed "Pat's Wake," and, of course, it aimed to be humorous.

R. R. TELEGRAPHERS WILL NOT STRIKE

But Will Contribute \$60,000 Towards the Campaign Fund.

Chicago, Aug. 15.—At the conference held here last night between President Small and Secretary Russell, of the Commercial Telegraphers' Union of America, President Samuel Gomper, of the American Federation of Labor, and several other labor leaders, it was decided definitely that there should be no strike of the 47,000 railroad telegraphers of the United States. The operators will be called upon shortly to contribute a strike fund of \$60,000. Two of their general officers attended the conference.

Cy Warman Trifles With a Moose: Has Narrow Escape From Death

Author Tries to Capture Deer in Lake—Not a Fake.

Temagami, Ont., Aug. 15.—Cy Warman, the well-known writer, had a narrow escape from drowning trying to capture a big bull moose in the lake at Temagami Inn.

Warman came to Temagami early last week from his home in London, Ont., on a fishing trip, with two friends, Rudolph Kauffmann, managing editor of the Washington Evening Star, and United States Consul J. E. Jones, of Winnipeg. The party visited several of the smaller lakes and caught many black bass. Moose were seen everywhere, no less than twenty being counted among the lily pads, where they had come to escape the flies and feed on the tender roots.

Warman thought he would like to catch a moose, and add that adventure to his book of experiences. Notwithstanding the protests of his Indian guides that moose when aroused are very dangerous, Warman insisted he would take a chance.

A big bull moose was located in a small bay. Cautiously advancing when the animal's head was under water, and remaining absolutely still when it appeared, Warman's canoe was soon between the moose

and the shore, cutting off his retreat in that direction. When finally the moose discovered Warman, he gave a snort and swam off in the direction of Camp Charlton.

Warman bade his Indian paddle alongside the frightened animal, and when he did so he reached over and patted the moose on his back; then he reached out and pulled the animal's ear, and pushed the ponderous head under water. This was too much even for a moose, and he stopped swimming. A moment later Jim Friday, an Indian guide, yelled:

"Look out, he is going to prong you!"

The caution came too late, for the infuriated moose jammed his antlers into the frail canoe and attempted to strike it with his front feet. Realizing his perilous position, the guide paddled as fast as he could from the scene. The canoe, badly damaged, filled rapidly, and Warman was rescued by his friends. It was a close call, and the Indians had a pow-wow over the incident that night after the smudge had gone out.

Warman declares he will not write the story of the moose chase, as he has heretofore enjoyed a reputation for veracity, and does not care for the classification of nature fairy. His companions vouch for the incident, and have dubbed Warman "Cymoose Warman."

Local Telegraphers Still at Work; Striking Operators Make Statement

London Managers Claim Everything Is Going All Right—Business Fair.

The local telegraph situation shows no change. Both the G. N. W. and the C. P. R. men are working, and have received no orders to go out on strike.

"We have done about two-thirds of our usual business," said Mr. W. C. Furness, of the G. N. W. "We have connections with Buffalo and Detroit and can get New York and Chicago through them. We are doing considerable American business. I do not expect any more men to go on strike."

The strike in Toronto and Montreal shows no change. The officials claim that they are filling the strikers' places and that they are doing nearly the usual run of business. The men claim that this is a mistake, and last night they issued a statement.

Pitiable Case of English Girl Shows The Need of Tuberculosis Hospital

Mrs. Tilley Explains the Case of the Young Lady Who Is Being Sent Back to England.

In the following very interesting letter to The Advertiser, Mrs. E. N. Tilley, a lady who has always taken a deep interest in the welfare of her fellow-creatures, gives full particulars in regard to the fund raised for the purpose of sending a certain English girl, who is suffering from tuberculosis, back to her home in England.

After giving great praise to all who contributed to the fund, Mrs. Tilley draws a pointed lesson from the case, which emphasizes the need for a tuberculosis hospital in London.

The letter is as follows:

Editor of The Advertiser: Dear Sir: You will be gratified to know, that through your kindness in

printing my appeal to the public, on behalf of the sick English girl, it has met with the most ready and generous response. The appeal appeared in your issue of the 7th and by the 10th the \$50 I asked for was sent to me. I found after sending my letter to the press, that I should need more to meet all requirements, so I wrote a few personal notes, and obtained all I needed. The London papers must have a large circulation outside of London, for contributions came from Lucan, Lucknow, Lobo, Liskeard, Crumlin, Granton, Glendale, Wyoming, Wallasey, Cairo, Mount Brydges and Montreal.

The interest and sympathy expressed by contributors has been great. Fathers and mothers gave "because they had a daughter of their own." A hard-working market woman stopped her cart at my door, and brought me 50 cents from herself and 25 cents from her son. The child-

Vancouver City Bonds Sold for 90

A dispatch from Vancouver, B. C., is of much interest to London financial men and also to the civic representatives. It stated that Messrs. Aemilius Jarvis & Co., of Toronto, had purchased \$100,000 of the city of Vancouver debentures at 90 and accrued interest. These debentures bear 4 per cent interest, and it is understood that they are repayable at the end of twenty years. Both the end of the city are to be met in Vancouver, Toronto, New York and London, England. This is part of a block of bonds, amounting to half a million of dollars, which were to have been purchased about a year ago by a Toronto firm of brokers at about 99½, but owing to the bonds not being valid at that time they refused to carry out the transactions. After special legislation authorizing the issue passed by the British Columbia Legislature, Messrs. Aemilius Jarvis & Co. submitted the offer which has just been accepted. It is claimed that this firm of brokers have obtained a two-months' option on the balance. The price compared with the price offered a year ago represents a loss to the city of Vancouver of about \$50,000, but when grouped with what was paid a short time ago for \$200,000 city of Hamilton debentures, which the same firm obtained at 90, Vancouver can be said to have got fairly good value.

City Will Advertise for an Inspector

Teachers Are Scarce But Scarcity Is Not as Great as in Past Years

Facts Concerning the Attendance at Local Collegiate—Opening of Rural Schools.

The rural schools open on Monday next, Aug. 19, and already the teachers are making their way to their positions. The city schools will not open until the Tuesday after Labor Day, and the country boy is feeling that he has lost a few weeks that he could spend with much more pleasure. The mandate of the authorities must be obeyed, however.

Teachers are not so scarce this year as last, nor the year before. This is, although they are none too plentiful yet. A more optimistic opinion seems to be prevalent concerning the teaching profession, and improved conditions are reported by the educational department.

For the first half of last year, the department received 352 applications for temporary certificates, while for the same period this year only 227 have been received. During the vacation last year the department was deluged with applicants for temporary certificates, but this year only six were received.

A Considerable Shortage. Still, there is a considerable shortage of teachers. The situation is eased up some, but the problem is by no means solved. The department are hoping that the general raising of salaries, the greater confidence of teachers in the situation, and the better

Collegiate Attendance. A comparatively large number of students passed the entrance this year, and the London Collegiate will have as many in attendance as last year, probably more. Not 50 per cent of those who pass the entrance go to the Collegiate, and after that the thinning-out process is rapid, and only a small percentage continue to the highest grades. The attendance last year in the lower school was 691, while the attendance for the upper school was only 105. This is the ruling ratio and shows little variation from year to year.

It is sometimes claimed that the Collegiate is for the sons and daughters of the richer classes, but this is not borne out by statistics. The occupation of the pupils' parents is given as follows: Commercial 311, agricultural 191, mechanical 329, professional 124, laborers 62, without occupation 43. The children of the working men are well represented, as they should be, and shows the democratic nature of Canadian educational institutions.

They are divided in their religious beliefs as follows: Methodists 342, Presbyterians 285, Episcopalians 233, Congregationalists 15, Roman Catholics 92, Baptists 74, other denominations 13.

GREAT FIRE AT OLD ORCHARD BEACH; 17 HOTELS AND 60 COTTAGES DESTROYED

Half a Million Dollars Damage Done to Famous Maine Resort.

Two Lives Were Lost and Five Persons Were Seriously Injured.

Old Orchard Me., Aug. 16.—Two lives were lost and five persons were injured, three seriously, as a result of

of the fire which swept through this resort last night, causing a loss of from half a million to three quarters of a million dollars. The dead: Philip Partridge, of Kennebunk, killed by locomotive while crossing track on way to fire. Unidentified man.

Rev. Rufus Jones, pastor of Trinity Church, Saco, seriously hurt by explosion of soda tank. Newton Morrill, Salem, Mass., Boston and Maine engineer, seriously hurt by same explosion.

Emerson, father of proprietor of Hotel Emerson hurt by same explosion, also an unidentified man, probably fatally injured. Miss Minnie, of Kennebunk, badly bruised by

being thrown from carriage in which she was riding with Partridge.

The injured are being treated at hospitals in Bliddeford. Seventeen summer hotels, sixty cottages and a score of buildings occupied by stores were destroyed.

The explosion occurred in Hogan's drug store, on Old Orchard avenue. It is believed that the fire started from an overlighted lamp. The total insurance on the burned property, it is said, will not exceed \$150,000.

Old Orchard, Me., Aug. 15.—Nearly one-half of Old Orchard's summer hotel section along the shore front was destroyed last night.
