he Debate in the House of Commons -Hon. Geo. E. Foster on the Question.

Ottawa, July 4 .- At the afternoon itting of the house, Mr. Flint's provincial prohibition resolution was called up after ten weeks' adjournment, The motions before the house were three-Mr. Flint's for, provincial prohibition, Mr. McClure's for general prohibition, and Mr. Parmalee's amendment declaring that the country is not ripe for prohibitory legislation

Mr. Flint, Liberal, said that, despite the resolution which stood in his name, no one could pretend that either he or the Dominion Alliance, which he represented, had ever taken any lower position than that prohibition ought to be extended to the whole Dominion of Canada. But, in order to secure additional support, and to meet secure additional support, and to meet the views of men who under present circumstances were not prepared for so sweeping a measure, he had offer-ed the resolution which stood in his name. At the same time he desired it to be understood that he intended to support the amendment offered by Mr. McClure, which he hoped would be carried. There was no use in denying that on this question the opinion of Quebec was emphatically divergent from that of the other provinces. He believed that if a prohibitory law were believed that if a prohibitory law were passed it would be supported and enforced by the general opinion of the country. Mr. Flint also made a brief reference to the question of how the public revenue would be affected by the enactment of prohibitory legislation, but he did not attempt to go at any length into this phase of the subject

FAVORED COMPENSATION. Clarke Wallace said that Mr. Flint was becoming quite moderate. Four of five years ago he said this was a question of the gravest possible importance. Now it was merely an interesting theme for discussion. Mr. Wallace was not in favor of shilly-shallying. He had always been in favor of abolishing the liquor trade, with compensation to all who had been legally engaged in the manufacture and trade. He estimated that it would cost eight or nine millions, involving an interest charge of perhaps a quarter of a million, which would be a mere triffe in comparison with the benefit secured. Provincial prohibition might accomplish something in Manitoba or Prince Edward Island. But with the manufacture and trade in full blast in Quebec, it Wallace was not in favor of shilly-Island. But with the insulateure and trade in full blast in Quebec, it would be useless for neighboring pro-vinces to legislate in Mr. Flint's fashion. Mr. Wallace said he was forerly interested in hotel proper-ties, and could not advocate compen-sation. But he had now no interest of this kind, and was free to express the opinion that the proper course of parliament was to enact a law which the departments of justice, of customs and inland revenue would assist

enforce, and which would also have the support of the interests now concerned in the traffic.

Mr. McDonald, Liberal, Huron, said he was a prohibitionist, and always had been, but apart from politics, had been, but apart from politics, he was now of the opinion that the country was not ripe for total prohi-bition. He did not blame the Government for refusing to introduce a prohibitory law, and asserted that F. S. Spence and Mr. Mcharen, of Toronto, both leading members of the Temperance Alliance, had told him that the results of the plebisoite had convinced them that a prohibitory convinced them that a prohibitory law could not be effective. He could not now propose an amendment, but

if the opportunity came later he would move one, stating that the country was not ripe for total prohibition, but that it was desirable to enlarge the scope of the Scott Act.

Mr. Craig, Conservative, Durham, thouhgt the time had come for members of their comions homestly. bers to give their opinions honestly The fact was that we had not a prohibitionist government or a prohibi-tionist parliament or a prohibitionist people. No legislation of this kind

people. No legislation of this kind would be effective. He would vote for Mr. Parmalee's amendment.

Sir Wilfrid Laurier said, as leader of the House, he thought he ought to give his views. The plebiscite was persented to the people, as the propersented to the people, as the pro-hibitionists wanted it. Immediately, after the vote he had declared that public opinion did not call for prohipublic opinion did not call for prohibition. He did not place the year against the nays, but those in favor of prohibition against the rest of the people. The discussion which had taken place since had justified the course taken by the government. Messrs. Flint, McClure, Craig, McDonald and Wallace, who had spoken, were all prohibitionists, but no two of them were agreed as to the duty of parliament in the matter. He (Sir of parliament in the matter. He (Sir W. Laurier) was sure that the House W. Laurier) was sure that the House would not adopt so radical a resolution as that of Mr. McClure's for immediate and total prohibition. As to Mr. Flint's provincial prohibition scheme, the Premier said this was the most dangerous idea of all. Even supposing it were constitutional, it would still be unwise to legislate on sectional lines. This scheme would intensify the line of cleavage. Ail the great distilleries and breweries and all the trade would centre in Quebec, which might gain somewhat, but it which might gain somewhat, but it would antesify the line of separation, and it was the duty of parliament not to separate the provinces by legislation, but to unite them. We should legislate for all provinces alike. For his part he was of the confirm that the country was not alike. For his part he was of the opinion that the country was not ready for prohibition. In his own province the temperance sentiment was as strong as anywhere. In county after county on both sides of the St. Lawrence no liquor could be bought under the law or against it, but the sentiment of that province was against compulsion in the matter. After referring to the growth of temperance sentiment. Sir W. Laurier said he was as much a temperance man as many prohibitionists, though he admitted that he was not a prohibitionist. He believed the Scott Act was a good law, and had been of

greet service. It was no use for any set of people to try to be wiser or better than the rest. He believed in education and in legislation when the country was ripe for it. It was quite true that his was not a prohibition government. He sat down without advising the house how to vote and without saying how he would vote himself.

HE CHARGES FALSEHOOD Mr. Foster said he proposed to vote against Mr. Parmaiee's motion. In the first place it contained false statements. It was not true that the affirmative vote in the plebiscite inaffirmative vote in the plebiscite indicated the quantity of prchibition sentiment in the country. It must be remembered that plebiscites had previously been taken by provincial governments. Nothing came of them, but the effect was to reduce the yea vote in the Dominion plebiscite. The people had seen the fallacy of these tests, and had grown restless. The vote did not represent the whole of public sentiment, because there were many who had no faith in the pledge of the Government. Mr. Foster wanted to know what would have been thought of the plebiscite pledge in the Ottawa platform if Sir Wilfrid Eaurier had spoken in the general election campaign as he had spoken to-day? Sir Wilfrid Laurier knew then as well as he did now what the sentiment was in his own province. Yet he went to the country with a platform which was intended to win

sentiment was in his own province. Yet he went to the country with a platform which was intended to win the favor of temperance people. Everywhere he gave the people to understand that the will of the people would prevail; nowhere did he say that he would require a majority of the total vote. The principles he now states were his two years ago and four years ago as they are to-day. Why, then, did he not be candid and honest with the people? Mr. Foster said he feared he had been instrumental in deceiving the people in 1898. He spoke, with the Minister of Agriculture, at a great public meeting in the spoke, with the minister of Agri-culture, at a great public meeting in this city. After Mr. Fisher had told the people that if they wanted prohi-bition they must vote for it, Mr. Fos-ter explained to them that the word of a minister must be accepted, and that if a majority of the vote polled was for prohibition, the law would be enacted. Mr. Fisher sat there and made no objection. Mr. Foster quoted Sir W. Laurier's replies to delega-tions of Christian bodies, and de-scribed the joy and hope his promises (now broken) produced. There was no word then of the majority of the registered vote, and the "implied registered vote, and the "implied agreement" now admitted to have been arranged beforehand in secret between the party leader and the op-ponents of prohibition. To-day Sir Wilfrid Laurier had taken the ground that these could be no prohibition without Quebec, and that Quebec was opposed on principle to prohibition.
This was direct notice that those who depended on this Government left hope behind. He would oppose Mr. Parmalee's amendment as draw-
