

LOCAL AND OTHER ITEMS.

Interpreted that Mr. W. A. O. Moran has been appointed Probationary.

Messrs. T. J. Harris of George Davis & Co. and James Fain of W. A. Weeks & Co. have returned from Great Britain where they were purchasing Goods.

An alarm of fire was sounded on Saturday noon for a small blaze at Elijah Partridge's, Kent Street. The fire was extinguished before the engine arrived and no damage was done.

The crew of the brig Lady Milton, from Caplin Bay, Charlottetown, which was abandoned in the winter, was rescued by the British steamer Legation, Captain Jackson, which has arrived at Liverpool from New Orleans.
