Damage by Floods in the Squamish Valley—Coal Output From Nanaimo Mines.

The Secretary of the Defunct Ainslie Lumber Company Arrested at Vancouver.

(Special to the Colonist.)

VANCOUVER, Oct. 1.—H. B. Wall, Secretary-Treasurer of the defunct Ainslie Lumber Company, of Portland, Oregon, was arrested here this morning, but released in an hour on his promise of going to Portland, for which he had tickets. The Ainslie Company failed July 7 last for half a million dollars, with assets nominally the same. When they started, a year ago, they made a mortgage on the house for \$105,000. There were arrears to the extent of \$100,000 at present. They had obtained large advances from Tacoma, Portland and San Francisco banks, but upon investigation, it was thought they had deliberately intended to defraud. Fifteen indictments of the Grand Jury are out against each of the three partners, and two others have already been arrested. Wall says he left Philadelphia for Portland as soon as he learned the company was in trouble.

Macdonald, Minister of the Interior, and understood definite arrangements arrived at between them to resignations. C. P. R. Land Sales. On Oct. 1, during the month of the C. P. R., sold 15,442 acres in the North-West, realizing \$50,057. For the same period, 4,976 acres were sold for \$17,978.

Prohibition in Manitoba. On Oct. 1, the total majority in the recent vote taken in the province was 12,522. Only two divisions in the majority against prohibition.

Prospective By-Election. On Oct. 1, it is said a likelihood that a bye-election will take place in the riding of St. John's, shortly, to fill the vacancy created by the death of T. C. Milne.

Steamer Ashore. On Oct. 1, the steamer Lake Huron, went ashore near St. Challoons, last evening.

Toronto's Assessment. On Oct. 1, the assessment figures for the city have been made public. They assessed value of the city to be \$100,000,000, as against \$100,000,000 for the year 1891. The decrease is owing to the city by law exempting from taxation machinery, plants and tools.

Provincial Legislature. On Oct. 1, the Local Legislature is not open until December, or later than was expected.

Glanders Frequent. On Oct. 1, Glanders has appeared in horses in this city. Already several have succumbed to the disease, and a number of others are affected. Steps are being taken to stamp out the disease.
