PRICE OF LIGHT WHEAT.

THE NEW PLAN OF DEDUCTIONS FAIRER TO THE FARMER.
Ottawa, Ont., Sept. 17.—It will be remembered that last year when a delegation from the Dominion Farmers' Association came to Ottawa to interview the Government regarding mixing of wheat, a question of more immediate importance came up, viz., the so-called deductions from the miller's price of wheat were made by millers when purchasing grain of the lighter grades from farmers. When wheat was a dollar a bushel the average deduction was about 10 cents, and when it was 80 cents a bushel the average deduction was about 8 cents. The new plan of deductions is as follows:—

When the price of wheat is 80 cents a bushel, the deduction is 8 cents; when it is 70 cents, the deduction is 7 cents; when it is 60 cents, the deduction is 6 cents; when it is 50 cents, the deduction is 5 cents; when it is 40 cents, the deduction is 4 cents; when it is 30 cents, the deduction is 3 cents; when it is 20 cents, the deduction is 2 cents; when it is 10 cents, the deduction is 1 cent.
