procedure and give its decisions by majority vote, provided that the Council may determine procedural questions in the event of any delay which in the opinion of the Council is excessive.

## Article 86

Appeals.

Unless the Council decides otherwise, any decision by the Council on whether an international airline is operating in conformity with the provisions of this Convention shall remain in effect unless reversed on appeal. On any other matter, decisions of the Council shall, if appealed from he currently the council shall, if appealed from, be suspended until the appeal is decided. decisions of the Permanent Court of International Justice and of an arbitral tribunal shall be first an arbitral tribunal shall be final and binding.

# Article 87

Penalty for non-conformity by airline.
