2. If this question relates to the Home Improvement Loans Guarantee Act and not to the Dominion Housing Act, no information can be given. Many home improvement loans are for the purposes of converting single unit houses into multiple unit houses but the information regarding the total number of family units provided is not compiled.

3. Applications for home improvement loans are made in the first instance to chartered banks and other approved lending institutions and they do not report the number of applications received.
