### RICHELIEU RIVER-REPORT ON DREDGING

Motion No. 20-Mr. Cardin (for Mr. Dupuis):

For a copy of each of the reports made by the economists and engineers of the Department of Transport, in connection with the possible dredging of the Richelieu river between the St. Lawrence river and lake Champlain.

Hon. Leon Balcer (Minister of Transport): Mr. Speaker, a similar motion was called on Monday. At that time I explained that these documents are departmental reports and that therefore they are privileged under the established practice of this house. Therefore I wonder whether the hon. member for Richelieu-Vercheres (Mr. Cardin) would be agreeable to withdrawing his motion.

Mr. Cardin: Mr. Speaker, I think the house will notice that all that is being asked for in this motion is the tabling of reports of economists and engineers of the Department of Transport. Owing to the wide interest that has been shown, and to the studies that have been made by organizations both in Canada and in the United States, I would urge the government and I would even insist that the government make these reports public.

# LABOUR CONDITIONS

REFERENCE TO EMPLOYMENT FIGURES IN DEPARTMENTAL RELEASE

On the orders of the day:

Hon. L. B. Pearson (Leader of the Opposition): I should like to ask the Minister of Finance whether, when he said last evening that employment had continued to increase in this country, he was aware that a dominion bureau of statistics publication issued this morning reported that over-all employment between the two quarters, that is the second and third quarters of 1960, remained unchanged.

Hon. Donald M. Fleming (Minister of Finance): I think I was aware of most of the statistics upon which the release which has been issued today was based. I think if the Leader of the Opposition will look at the release he will see that there were some 99,000 more persons employed on the date given in the release than were employed on the same date last year.

## GRAIN

INQUIRY AS TO INCREASE IN DELIVERY QUOTAS

On the orders of the day:

Mr. Hazen Argue (Assiniboia): I wish to address a question to the Minister of Agriculture arising out of the low grain delivery quotas in existence on the prairies, almost 1,300 of one bushel or less and 700 have a lower quota than this time last year. Can the minister hold out any hope or give any assurance that at an early date grain delivery quotas can be raised to the two or three bushel level?

Hon. Alvin Hamilton (Minister of Agriculture): Deliveries of spring wheat grades have been held back this year until a few weeks ago because of our success in selling oats and Durum wheat, thereby increasing the cash income to farmers in western Canada. I think all the indications are that we shall be catching up with spring wheat quotas in the next few months or so. I should like to emphasize that what really counts is the number of bushels sold by farmers to the elevators, which is higher this year than last year.
