## INQUIRY AS TO INTRODUCTION OF AMENDING LEGISLATION

Hon. Marcel Lambert (Edmonton West): Mr. Speaker, my question is addressed to the Minister of Labour. As a result of some confusion and uncertainty arising out of his clarification yesterday can the minister now advise the house whether, as a result of proposed amendments to the Unemployment Insurance Act, the employer-employee relationships which are to be broadened will include registered nurses? Will the minister also indicate to the house when he anticipates that this legislation will be brought forward so this whole question can be settled in the minds of the public?

Hon. J. R. Nicholson (Minister of Labour): Mr. Speaker, it is our hope that this legislation will be brought forward at an early date. We already have a pretty full legislative timetable, but this matter is of great importance and will be brought forward as soon as possible. At that time the extent of the changes recommended by the government will be disclosed in the bill. If there should be any extension of the trend toward universality this will be based on the employer and employee relationship. I might say that this is a trend which has occurred over a period of years. It is a gradual trend, and there has been no specific decision as yet for any extension.

Mr. Eldon M. Woolliams (Bow River): I have a supplementary question. Will the Minister of Labour indicate whether his government has abandoned the idea of increasing to \$65 the weekly amount now paid under the **Unemployment Insurance Act?**
