DOMINION-PROVINCIAL RELATIONS

ASSISTANCE TO PROVINCES TO MEET EDUCATION COSTS

On the orders of the day:

Mr. John Lundrigan (Gander-Twillingate): Mr. Speaker, my question is for the Prime Minister. Will the Prime Minister take advantage of the opportunities provided by the impending conferences with the provinces to begin discussion of an acceptable and constitutional arrangement to allow extensive federal financial assistance in meeting the crisis in education in Canada.

Right Hon. P.-E. Trudeau (Prime Minister): Mr. Speaker, the matter of the division of jurisdiction as between the federal and provincial governments is also on the agenda. It is possible some of the provinces might suggest transferring educational jurisdiction to the federal government. I have no information on that.

Mr. Lundrigan: I hope I did not suggest to the Prime Minister that there should be a transfer of jurisdiction over education to the federal government. I asked whether some acceptable constitutional arrangement could be provided. I have a supplementary question. Have any discussions of this kind already been held with the provinces regarding financial assistance in the field of education, and could the Prime Minister say what was the nature of those discussions?

Mr. Trudeau: Well, in the past couple of years the federal government has vacated tax room for the provinces so they could increase by hundreds of millions of dollars their expenditures on education.

Mr. James A. McGrath (St. John's East): Has the right hon. Prime Minister received a specific request from the province of Newfoundland in the area of education.

Mr. Trudeau: Not that I am aware of.

Mr. Bernard Dumont (Frontenac): Mr. Speaker, can the Prime Minister tell us if, at the next federal-provincial conference, he will take into account the recommendations made by the Aird commission in 1927?
