### RHODESIA—GIFT OF FUEL FROM ORGANIZA-TIONS IN CANADA

On the orders of the day:

Mr. David Lewis (York South): Mr. Speaker, yesterday my colleague the hon. member for Vancouver-Kingsway asked the Secretary of State for External Affairs a question with regard to the gift of 1,500 gallons of gasoline from Friends of Rhodesia organizations in Canada. The article to which she referred carried a picture with the legend: "The gift indicates the sympathy and support of the Canadian people." The minister promised to look into the matter and read the article. My colleague has gone, and asked me to ask the minister whether he has been able to look into the matter, and has any comments to make about it.

Hon. Paul Martin (Secretary of State for External Affairs): Mr. Speaker, according to reports which we have received, 1,500 gallons of petrol were turned over to the illegal Smith régime at the end of October by a Mr. Ronald Gostick who was acting on behalf of the Friends of Rhodesia societies in Canada. The article to which the hon. member for Vancouver-Kingsway called my attention itself points out that the delivery of the fuel was made from South Africa.
