postal slowdown in the city of Montreal which has crippled mail service, a concern 326 and 341 be deemed to have been adopted? which is within the administrative responsibility of the government of Canada and which has presently reached crisis proportions.

## [Translation]

Mr. Speaker: The hon. member for Peace River (Mr. Baldwin) has given the Chair the required notice under Standing Order 26. I must inform hon, members of the concern and uncertainty which I feel about the motion brought in by the hon. member.

On the other hand, I do not think that I can leave out of consideration the virtual commitment I gave the Leader of the Opposition (Mr. Stanfield) and hon. members, when I suggested that before that question could be examined by the House, it would be advisable to wait for the results of talks between the minister and the labour representatives. It seems that those talks were not successful or fruitful as it could have been expected. Under the circumstances, and in view, as I said, of the position which I ventured to take yesterday, when the motion was brought in by the Leader of the Opposition, I think, even with my misgivings and concern about that matter, that I should put the motion to the House.

And having come to this decision, I am asking the House if the hon. member for Peace River has leave to introduce the motion in order that the matter mentioned by him earlier may be discussed.
