STRIKE OF GRAIN INSPECTORS—BASIS OF OFFER TO EMPLOYEES—GOVERNMENT ACTION TO SETTLE

Mr. Jack Murta (Lisgar): Mr. Speaker, I should like to direct a question to the President of the Treasury Board. In view of the fact it has been reported that the justification used by the federal Treasury Board for denying grain inspectors wage increases comparable to those given to grain handlers in Vancouver is based on the premise that the inspectors, who are federal employees, do work that is unrelated to the grain handlers who are employed by private grain companies, could the minister explain how this can in any way be considered logical? The federal government, by law, forced the private companies to pay an increase of between 54 per cent and 61 per cent, but now refuses to grant its own employees an equal increase to even one-quarter of the amount that was granted previously?

Hon. Jean Chrétien (President of Treasury Board): Mr. Speaker, the grain inspectors have chosen to strike and they are perfectly entitled to do so. The board of conciliation presented both a majority report and a minority report. The latter, written out by a union representative, accomplished far less than the act passed last fall. I fail to see therefore why the Treasury Board should offer more than was suggested by the union representative to the conciliation board.

Mr. Murta: Mr. Speaker, a supplementary for the President of the Treasury Board. In all sincerity I say to him that I do not believe the government is aware of the seriousness of the present situation. In talking with grain company officials in Winnipeg this morning it became apparent that we are faced with loss of sales in the next two or three days unless something positive is done. Since the grain industry is being brought to its knees because of the strike, may I ask the minister what positive and immediate measures the government is considering in order to get grain moving again or does it intend just to sit around and wait?
