HARD RED SPRING WHEAT—ACTION TO CORRECT DISCRIMINATION RESPECTING QUOTAS—MOTION UNDER S.O. 43

EL SALVADOR—CALL FOR CONDEMNATION OF JUNTA—MOTION UNDER S.O. 43

That this House calls on the Government of Canada to condemn the junta of El Salvador, to protest clearly and openly the continued and increasing military support of that junta by the United States, and take international initiatives to assure the safety, health and lives of Salvadorian human rights and community leaders.

CALL FOR REJECTION OF IMPOSITION OF FEDERAL TAX ON PROVINCIAL RESOURCES—MOTION UNDER S.O. 43

**Mr. Thomas Siddon (Richmond-South Delta):** Madam Speaker, I rise under the provisions of Standing Order 43 to propose a motion of urgent and pressing importance to the future of our country. Given the fact that during the short period of two weeks more than 10,000 residents of British Columbia have already signed a petition in which they express their absolute rejection of any attempt by the Government of Canada to impose a discriminatory federal excise tax against the export of natural gas and hydroelectric power from British Columbia, and recognizing also that the mayors and municipalities of British Columbia, meeting in convention last month, passed a resolution unanimously opposing a federal export tax on natural gas, I therefore move, seconded by the hon. member for Fraser Valley West (Mr. Wenman):

That this House rejects absolutely the unilateral imposition of any federal export tax on provincial resources and hereby directs the government to abandon its planned export tax on natural gas, which would discriminate blatantly and unfairly against the residents, the municipalities and the provincial governments of British Columbia and Alberta.
