POWERFUL DISCOURSE AT FIRST BAPTIST CHURCH

"Put Your Prayers and Ballot into the Same Box" Says Rev. W. E. Matthews at Conclusion of Tremchant Sermon

Last evening Rev. W. E. Matthews at the First Baptist Church gave a very telling and well thought out address on "The Church and the Whiskey Business" before a large congregation...

The liquor traffic is the most subtle foe encountered by the church; with this iniquitous business the church can make no compromise...

The preacher went on to say that the continent-wide movement against the liquor institution has reached Manitoba. Whatever the immediate result, things can never be as they have been...

Overcrowds All Else It is our profound conviction that the most issue in the pending election overshadows all other questions...

The one question for every Christian citizen to settle in his own mind is this: In the present set of circumstances at this given time in this province in relation to the liquor traffic, what should I do that should promise the greatest curtailment of the influence of the whiskey business?

This is not, said the preacher, the place to enter on the many arguments pro and con regarding the relative efficacy and a restricted license system on the one hand, and banish the bar on the other...

the whiskey business if the Christian elector will settle the question of his attitude toward it as a matter of conscience. "Apart from all quibbling, technicalities, and political partisanship, the one thing that the organized moral forces of this province mean to do, is to banish the bar, using such means as may be at hand for so doing and they are determined that if one means fail another shall be employed."

The Premier's Speech "The Premier of this province in his Neepawa speech declared that the temperance plank in the Liberal party is the most reactionary and retrograde suggestion that he had seen made by any party or individual in his fifteen years of office."

"In coming to any such conclusion one must do so in spite of three facts: (1) That those who have given themselves unsparingly to the work of moral and social reform, not only in Manitoba but in the mother province of Ontario, as well as in other parts of the land, believe that to banish the bar would be a decided step forward; (2) That increasing numbers of disinterested students of social and moral life of the people believe that the bar room is the sting of the liquor business, and the greatest menace to public welfare; (3) That the whiskey interests evidently do not consider banishing the bar a reactionary temperance movement, for if they did, why is every man of them, Grit and Tory, lined up against the possibility of any such proposed legislation?"

"Never was there a more sacred duty," concluded the preacher, "before the Christian electorate of Manitoba than that of casting an honest, God-fearing ballot on the 10th of July; let every man of us put his prayers and his ballot into the same box."

Fine Meeting On The Flats

Good Audience Listen To Liberal Candidate and W. de Manby

One of the surest indications of the political atmosphere in this city was disclosed at meetings held in support of the opposing liberal and conservative candidates on the flats on Saturday evening.

Readers of the signs of the time may draw their own inferences from the following contrast. Conservative meeting widely advertised only drew an audience of 12 people outside of the government officials.

While the efforts of the conservatives to get a meeting together proved absolutely abortive, the enthusiastic liberals of alien nationality were not content to let the week end pass by without finding an outlet for the bubbling enthusiasm for the progressive cause that now pervades

their ranks. The word that a meeting in support of the liberal candidate was to be held spread like wildfire in a few minutes, and hundreds of enthusiastic citizens flocked to the scene.

Messages were sent to S. E. Clement and W. de Manby, and in a few minutes these gentlemen arrived and were at once called upon to deliver speeches. It is needless to say that they received an ovation, and the whole proceeding showed how political sentiment was spreading in the northern section of the city.

99th Rangers Left Yesterday

134 Took Special Train for Sewell

At 10 a.m., yesterday morning the 99th Manitoba Rangers left for Sewell by a special troop train, 134 strong; this being the largest number they have turned out yet.

After parading in the Armory from 9 to 9.30 Companies A, B, and C, which comprise the Brandon corps, headed by 99th Regimental band proceeded down Tenth street to the C.N.R. station.

The officers in charge of the local companies were Major Kiockaldy, in command; Lieutenant and Adjutant Blake; Paymaster Sykes, Captain Whillier, Donaldson and Creelman; Lieutenants Kellet, Harrington, Lamontague, Whitchelo and Lewis.

At Sewell the local companies will be joined by the remainder of the regiment from Portage. The 99th will remain in camp for only five days, thus returning on Thursday.

Two Receivers Found Guilty

One Defendant Discharged, Two Remanded Till Thursday for Sentence

All Saturday afternoon's police court was taken up with the hearing of two out of the four cases in which defendants are charged with receiving the stolen brass from the four boys who were severely birched in the juvenile court last week for stealing same.

The other two cases were heard at the police court this morning, one, however, being dismissed. In each case defendants pleaded not guilty to the charge of receiving goods knowing them to have been stolen.

Mrs. Annie Rose and Mrs. Sackolinski were both heard on Saturday afternoon, and although they pleaded not guilty, Magistrate Bates found them guilty after a three and a half hours session of the court. He remanded their sentence, however, until Thursday, July 2, and allowed them out on bail at \$500 each.

Colonel Bruce appeared for the above two accused and after three of the boys had given evidence in the case against Mrs. Rose, in addressing his worship, Colonel Bruce stated that no truth could be gleaned from their stories since there were so many discrepancies in the boys' statements.

But Crown Prosecutor R. M. Matheson, in presenting the case, stated that he had more sympathy for accused before they went into the box than after. He could not conceive of her selling the truth. What could the boys hope to gain by giving evidence against her he asked. "If she is to be believed," he went on, "why five of the witnesses for the crown have sworn to what is false. On behalf of the crown," continued Mr. Matheson, "I ask you to find her guilty. The witnesses are bound to have this pilfering stopped and the only way is to stop those who encourage it."

Magistrate Bates took the view that the boys would naturally be hostile to the court after the punishment, and he could not think that they would now come into court and give evidence in its favor. If they were inclined to favor either side, he thought it would be the accused. He held that the little inconsistencies in their stories simply made it more to be believed. Concluding, he said he must believe the boys and he did not believe the accused in the box and he must therefore find her guilty.

Mrs. Sackolinski admitted that she bought the brass from the boys, but said she did not know that it had been stolen. It transpired in evidence that she had later sold the brass to Jacob Stein, but he had not taken it off her premises.

Mr. Matheson, in summing up the case, stated that the evidence applied here as in the case of Mrs. Rose, but it was doubly as great since she had purchased about twenty times the amount of brass.

Magistrate Bates stated that these cases had opened his eyes to the terrible crime which was going on in our city in regard to pilfering among the boys. "These women," he said, "are simply a training school for these boys and they

NEW G. N. R. TRAIN STARTS Commencing today, the Great Northern Railway have begun to run their train on the new schedule. Leaving Brandon at 12.35 noon and reaching Devil's Lake at 8.30 p.m., it makes close connection for St. Paul, Minneapolis and Chicago. Returning, it reaches Brandon at 6.40 p.m.
