MUNICIPAL COUNCIL IN ANNUAL SESSION

Patriotic Fund Assessment Main
Feature of the Session—
Other Business.

The annual meeting of the Restigouche Municipal Council convened at Dalhousie Tuesday at 11 a. m., Warden Murchie in the chair. The following Councilors were present: Grimmer—Couns. Peters, Lynch, Eldon—Couns. Copeland, Thomas, Addington—Couns. Harquail, Gillis, Dalhousie—Coun. Golden, Balmoral—Couns. Perard, Dutton, Colborne—Couns. McLean, Giroux, Durham—Warden Murchie, Coun. Lawlor. Town of Campbellton—Coun. C. A. Alexander.

Coun. Arsenau of Dalhousie parish was not in his accustomed seat much to the regret of all, as he is seriously ill at Quebec.

Minutes of P. M. session in July read and confirmed.

Council adjourned until 2 p. m.

TUESDAY AFTERNOON.
Council reassembled at 2 o'clock.

Minutes of morning session read and confirmed.

Coun. Lynch moved that H. R. Anselow be appointed official reporter. Carried.

An application for a moving picture license from Anderson was read and laid on the table for future consideration.

A petition from Jerome Gallant, asking for a reduction in the amount of license fee for peddling was read and ordered placed on file.

A communication was read from Simon Landry asking that a boom master be appointed for Eel River.

Coun. Golden, for the parish of Dalhousie promised to have such an officer placed in the parish list.

A communication from the Union of N. B. Municipalities was read. This asked the council to appoint a member to represent it on the Legislative committee as well as a delegate to the annual convention.

This matter was laid over until the July session.

Another communication from the Union of N. B. Municipalities asking the council to increase its annual fee to twenty dollars was read and this amount ordered paid.

A communication from the Executive Council of the local government, in reference to the Patriotic Fund assessment was read and laid on the table for future consideration.

Coun. Giroux moved a reconsideration of the motion voting \$20.00 to the Union of N. B. Municipalities—Carried.

Coun. Lawlor moved that the Municipality pay no fee to the Union.

Coun. Harquail spoke strongly in favor of paying the amount and Coun. Thomas spoke against it.

On a vote the motion was carried.

FUNERAL OF LATE THOMAS MALCOLM

Service in St. Andrew's Presbyterian Church Largely
Attended.

The funeral of the late Thomas Malcolm was held last Saturday and was very largely attended. A special train left Campbellton at 7.30 a. m. for Bathurst. There was a good representation of citizens aboard this train on its departure from here and on arrival at Bathurst was well filled, many others along the line having boarded it at the several stations it stopped at to take on all those desirous of attending the funeral. A short but very impressive funeral service was conducted at the residence of Mr. E. P. McKay at 11.30 a. m., by Rev. Hugh Miller, M. A., of Campbellton, assisted by Rev. Mr. Matthews of Bathurst, at which service two of the deceased's favorite hymns were most beautifully rendered. At the conclusion of this service the remains were tenderly borne to the hearse in waiting by the pall-bearers—His Honor Judge McLarty, W. F. Napier, Daniel Richards, Mayor Andrew, Dr. Pinault, H. E. Bray, James Patterson and Alex. McLennan—and conveyed to the special train at the depot, followed by a large concourse of people. The special left Bathurst about 12.30 for Campbellton many of Bathurst's prominent citizens accompanying the remains to Campbellton. On arrival here about 2.45 the remains were met at the depot by a large number of the deceased's friends, and were again tenderly borne to the hearse in waiting by the pall-bearers and conveyed to St. Andrew's Presbyterian Church where the pastor, Rev. Hugh Miller, M. A., conducted another most impressive funeral service, the choir of St. Andrew's Church rendering two more of the deceased's favorite hymns. At the conclusion of this service the casket was opened and all in attendance given an opportunity of viewing the remains of their departed friend before the last sad rites were to be performed at the Rural Cemetery. The funeral cortege from the Church to the burial ground was one of the largest witnessed in Campbellton for many a long year. Fred Dobson, about forty years of age, a lamp lighter on the C. G. R. was killed at the west end of the yard here about noon to-day. The body was badly cut up. The unfortunate man was a lamp lighter on the C. G. R., having been engaged about three or four months ago. As such it was his duty to fill and clean all the signal lamps here. He was engaged at this work this morning when the Ocean Limited came along and struck him in the back. He was thrown clear of the main line but directly on the rail in front of another moving train which cut the body completely in two. The unfortunate man is married and leaves a family, who will have the sympathy of all in their sad bereavement.

**SERIOUS SOFT COAL
SHORTAGE HERE**

Many Citizens Suffering From
Cold the Past Week—Some
Coming

A serious soft coal famine has been in evidence during the past week.

On Friday last neither coal dealer had a ton of soft coal, and the C. G. R. authorities were unable to deliver any cars on account of the heavy storms and also the shortage at present experienced on the railways.

As most of our citizens now burn coal, most of them using the soft, a great deal of suffering has resulted.

On Wednesday afternoon both R. K. Shives and W. T. Cook each received one car of coal, which was immediately unloaded and teams commenced delivering to those who needed it badly.

During the past two or three months the C. G. R., has been confiscating carloads of coal addressed to private parties, in order to keep their trains moving. Last week the management of the road decided to buy large quantities in the United States and thus relieve the shortage which our Canadian mines seem unable to cope with.

NEW RULES RE-SEPARATION ALLOWANCE
Ottawa, Jan. 13—New regulations regarding rates of separation allowances for officers and men of the Canadian naval service have been established by order-in-council. Seamen and petty officers of the 2nd class will receive \$20 per month, 1st class and chief officers \$25, warrant officers and sub-lieutenants and upwards \$40. In the case of one motherless child the separation allowance is to be \$12 and the term dependent is to be considered as including widowed mothers and motherless children.
