The Department of Foreign Affairs and International Trade (DFAIT) has taken the lead on the Convention ratification and universalization, as well as on international coordination, global priority-setting and monitoring Convention implementation. DFAIT is also working in cooperation with the Department of National Defence (DND) on AP mine stockpile destruction. The Canadian International Development Agency (CIDA), meanwhile, is taking the lead on demining and victim assistance. DND and the Department of Industry are cooperating on research, development and marketing of appropriate Canadian demining technologies.

Ministerial Appointment: Canadian Ambassador for Mine Action

Canadian Foreign Affairs Minister Lloyd Axworthy announced in May the appointment of Jill E. Sinclair as Ambassador for Mine Action. Ms. Sinclair is supported by the newly-created Mine Action Team within the Department of Foreign Affairs and International Trade.

"The appointment of an Ambassador for Mine Action and the creation of the Mine Action Team are positive steps in meeting our commitment to the Agenda for Mine Action," said Mr. Axworthy. "Canada is maintaining the momentum of Ottawa Process II and we are continually renewing our efforts in this important humanitarian initiative."

The post of Ambassador for Mine Action has been created to ensure that the Ottawa Convention is effectively implemented. The Mine Action Team is responsible for promoting the entry-into-force of the Convention, universalization, and the full implementation of its provisions in partnership with the Canadian International Development Agency (CIDA), the Department of Defence (DND) and Industry Canada.
