STATEMENT BY FORESTRY MINISTER RESPECT-ING ASSISTANCE TO EASTERN FARMERS

Mr. Clément Vincent (Nicolet-Yamaska): Mr. Speaker, may I put a question to the Minister of Forestry?

It follows from the statement made last night by the minister on television to the effect that the federal government will soon announce a comprehensive program designed to improve the standard of living of eastern farmers.

Could the minister tell us when this program will be announced and whether it will take into account the suggestions made by members of the opposition to establish a national dairy control board and a minimum price of \$3.50 per hundredweight for industrial milk?

Hon. Maurice Sauvé (Minister of Foresiry): Mr. Speaker, I believe that the first part of the question asked by the hon. member deals with a comment made by the announcer and not with a statement I made.

Indeed, yesterday I addressed the co-operative milling trade of the province of Quebec, which had gathered under the auspices of the federated co-operative. I spoke before those representatives of the agricultural sector and I stressed the necessity for co-operation between the provincial governments and the federal government so as to improve living conditions in rural centres and particularly in the agricultural field.

I raised many problems, but I did not announce any policy, and if my hon. friend would only read the text of my speech—

Mr. Vincent: Mr. Speaker, may I ask an additional question?

Does this mean that the present government has no legislative program to announce within a few days, a few weeks or a few months, to raise the standard of living of farmers in the eastern provinces?

Mr. Sauvé: My remarks had nothing to do with the legislative program of the government.
