AGREEMENT ON SCHOOL BUS PRICES

Guy Favreau (President of the Privy Council): I am informed that the office of the director of investigation and research under the Combines Investigation Act has received no complaint about price fixing by the manufacturers of school buses in eastern Canada. I would suggest that if the hon. member or any other persons have any information that would indicate price fixing in this industry, they should bring it to the attention of the director in order that he may consider whether formal inquiry is warranted.
