Hon. Ron Basford (Minister of Consumer and Corporate Affairs): Mr. Speaker, I should like to table in both official languages a report of the Prices and Incomes Commission concerning a review of manufactured edible oil products.

For example, Stills Photo personnel have been deleted from the Production Branch figures, and cameramen have been included although previously they were in the Technical Operations Branch.

2. (a) No. The NFB expects to receive \$130,000 above the sum of \$300,000 in 1970/71. (b) Since the suspension of the film rental charges, the NFB has taken steps to ensure that, with its available resources, service to the public would suffer as little as possible.
