REGIONAL ECONOMIC EXPANSION

POLICY RESPECTING GRANTS—CONTROL OF COMPANIES—ASSISTANCE TO SWIFTS

Mr. Eldon M. Woolliams (Calgary North): Mr. Speaker, I should like to ask a question of the Minister of Regional Economic Expansion. Is it government policy, in reference to regional development, to advance money to Canadian companies in preference to American controlled companies?

Hon. Jean Marchand (Minister of Regional Economic Expansion): No, Mr. Speaker.

Mr. Woolliams: I wonder if I might ask a supplementary question, Mr. Speaker. Can the minister justify his position, in light of that of the Minister of Energy, Mines and Resources, by explaining to the House and the country why he is advancing to Swift's in Lethbridge several hundred thousand dollars to go into operation against Canadian owned and controlled companies? Why is he advancing money to United States companies that are not here already?

Mr. Marchand (Langelier): Mr. Speaker, in our regulations concerning industrial loans or incentives, we do not take into account the origin of the company but only the place where materials for the construction of industries are bought. There is no discrimination against businesses with regard to their origin.
