### Question No. 1,350-Mr. Orlikow:

- 2. How many employees is it estimated there will be in the Executive Category in the national capital region by 1975 and, of these, how many will be bilingual?
- 3. What was the annual rate of turnover in the Executive Category by way of retirement, dismissal or resignation in the past five years?
- 4. What is the estimated rate of turnover in the Executive Category by way of retirement, dismissal or resignation in the next five years?
- 5. What is the government's target for bilingual employees in the Executive Category in the national capital region by 1975?
- Hon. C. M. Drury (President of the Treasury Board): 1. As of September 1970, there were 503 employees in the Executive Category. The number of bilingual employees located in the national capital area is not presently available.<sup>1</sup>
- 2. The number of employees in the Executive Category in the national capital region in 1975 will depend on policy and program decisions not yet made. In the four year period from 1966-70 the number of employees in all categories in the national capital region increased by 14 per cent.
- 3. 1965-66, 7.5 per cent; 1966-67, 5.0 per cent; 1967-68, 6.6 per cent; 1968-69, 6.1 per cent; 1969-70, 5.9 per cent.

On April 7, 1971 letters were dispatched to the Premiers of New Brunswick and Nova Scotia outlining arrangements for the proposed federal-provincial review of the Atlantic Tidal Power Programming Board findings. The Premier of Nova Scotia has advised that these proposals require further consideration by his government and he undertook to convey that government's reaction upon his return from Europe in mid-May. It is not possible to provide the information requested in question No. 1,369 until the Premier of Nova Scotia advises as to his government's reaction concerning the proposals advanced for the federal-provincial review.
