POSSIBLE IMPORT OF LIQUIFIED GAS

Mr. Claude Wagner (Saint-Hyacinthe): Mr. Speaker, I should like to direct a question to the Minister of Energy, Mines and Resources.

Is it true that Canada is getting ready to export next year on the American market, 38 per cent of its production of natural gas and that in the event of such exportation, the province of Quebec will have to import liquified natural gas from Algeria—at double the Canadian price—to meet its consumption increase?

Hon. Donald S. Macdonald (Minister of Energy, Mines and Resources): Mr. Speaker, our current export contracts were authorized until 1971 but since then the National Energy Board has not yet authorized exports, excess exports to the United States. The board is having a series of meetings to prepare a report on natural gas production for Canadians and we are waiting for the report from the National Energy Board. But it is not true that the Board recently authorized the exportation of natural gas.

POSSIBLE PARTICIPATION OF MINISTER IN APPROVAL OF ADVERTISING CONTRACT AWARDED PRICE, RUBIN AND PARTNERS BY DEPARTMENT

Mr. Walter Baker (Grenville-Carleton): Mr. Speaker, in view of the minister's answer and the contention that this matter may have been approved in the normal way, may I direct a supplementary question to the Minister of Labour. If the contract was approved in the normal way, as has been described, and in view of the personal relationships alluded to in the report, will the minister assure the House that he stayed out of the government's decision on this matter? Or, did the minister participate in that approval in the normal way and recommend this firm for that contract with his ministry?

Hon. John C. Munro (Minister of Labour): Mr. Speaker, I should like to make it clear to the House and to the hon. member that the contract to which the hon. member referred was approved in the area of multiculturalism. The firm had been awarded that contract by the previous minister and it is carrying on, certainly, with my support. There is no question about that. I should like to make it clear for the record, and this is important, because this matter involved an ex-law partner of a cabinet minister and their ex-law partner happened to be approached to be a director of a firm, that I have sold my interest in the firm. Prior to the last election I filed my income tax statement, unlike any other member of this House, with the press—

Mr. Munro (Hamilton East): —and this clearly indicated that I have sold out my interest and I have no interest whatsoever in this particular law firm.
