ADMINISTRATION OF JUSTICE

USE OF OFFICIAL LANGUAGES IN COURTS

Mr. Eldon M. Woolliams (Calgary North): Mr. Speaker, my question is for the Minister of Justice. In light of the debate on Bill C-42, language in the courts, that will continue this afternoon, perhaps the answer to my question will shorten it. I suggested in my speech, on behalf of the party, an amendment under which, if the act is to come into force, it would be jointly proclaimed not only by the federal government but by the provincial governments, if the law is to be adopted by the provinces, in line with the administration of justice which falls under provincial jurisdiction. Would the Minister of Justice comment on that matter, because I am sure it would shorten the debate?

Hon. Ron Basford (Minister of Justice): Mr. Speaker, without getting into a debate with the hon. member, I take some exception in light of my view that the legislation as presented is perfectly constitutional. As I have already indicated, I have not taken a firm position on the proposed amendment. I am having my officers examine it from a constitutional and policy point of view. I have indicated to my colleagues that I want to discuss this matter with them early next week so that I will be in a position to respond to the hon. member in committee if the bill gets that far.

EXTERNAL AFFAIRS

UNREST IN SOUTH WEST AFRICA

Mr. Lloyd R. Crouse (South Shore): Mr. Speaker, I wish to direct my question to the Secretary of State for External Affairs. As the minister is aware, there has been dissatisfaction expressed by members of the United Nations over the mandate exercised by South Africa over South West Africa, and South Africa has indicated that they will keep their 15,000, approximately, troops in South West Africa just as long as Cuba keeps a similar number of troops, revolutionaries and mercenaries on the southwest Angola border.

My question to the minister is: Has he asked Cuba to withdraw these troops, in the interest of establishing peace in this much troubled area? Also, since it is my understanding that he was delegated as a spokesman to make a presentation which would solve this problem to the South Africans, has his concept been accepted and has SWAPO, the South West African People's Organization, accepted his proposal to establish peace in South West Africa?

MANPOWER

REQUESTED PROGRAM FOR SHOEMAKER TRAINING

Mr. Arnold Peters (Timiskaming): Mr. Speaker, I would like to ask a question of the Minister of Unemployment and Immigration. Following some inquiries I made of Manpower, I understand there is no training provided for shoemakers. In light of the fact that shoes are very expensive in northern Ontario, and we could use a number of shoemakers to do repairs, will the minister give consideration to implementing a program of shoemaker training under Manpower facilities?

An hon. Member: It is against their contract.

Hon. Bud Cullen (Minister of Employment and Immigration): Mr. Speaker, the initiative and responsibility is provincial in providing the particular sources. Under the various adult occupational training programs, or the \$96 million we make available for apprenticeship programs, we must work in agreement with the provinces. I have the hon. member's representation. I know his "soul" is in it, and we will give it every consideration.
