Because this radioactive spill contained large amounts of tritium, a substance so toxic that some scientists believe it can cause birth defects, and because it is a substance for which there are no proven safety levels for emissions, I move, seconded by the hon. member for Skeena (Mr. Fulton):

That the Minister of Energy, Mines and Resources immediately instruct the Atomic Energy Control Board to conduct a complete review of all their general radiation emission standards to protect the health of this and future generations of Canadians.
