TABLING OF DRAFT REGULATIONS

Hon. Kim Campbell (Minister of Justice and Attorney General of Canada): Mr. Speaker, pursuant to subsection 116(2) of the Criminal Code, as enacted by subsection 28(4) of an act to amend the Criminal Code and the Customs Tariff in consequence thereof, and pursuant to Standing Order 32(2) I would like to table, in both official languages, the following draft regulations: cartridge magazine control regulations, firearms acquisition certificate regulations, prohibited weapons control regulations, restricted weapons and firearms control regulations, storage, display, camping and transportation of certain firearms regulations, and genuine gun collector regulations.

UNEMPLOYMENT INSURANCE ACT

They are calling upon Parliament to take immediate steps to specify that accidental violation of the Canadian rail operating rules does not constitute employee misconduct under sections 28 and 30 of the Unemployment Insurance Act.
