CANADA POST CORPORATION ACT

MEASURE TO AMEND

The House resumed consideration of the motion of Mr. Andre that Bill C-73, an act to amend the Canada Post Corporation Act, be read a second time and referred to a legislative committee in the Departmental envelope; and the amendment of Mr. Boudria (p. 10744).

Mr. Ron MacDonald (Dartmouth): Madam Speaker, it is an interesting bill we are debating here today. It is one of these bills that in the future we would always be able to go back to, if the government had the opportunity to govern much longer, which it will not, and there would be a wealth of denials about the actual intent of the government when it introduces pieces of legislation.
