The Select Committee to whom was referred the Bill intituled: "An Act for the relief of "*George W. Jones*," have the honor to report :

That having heard the said *George W. Jones* and the respondent, his wife, *Ann Catherine Jones*, by their Counsel, and having heard the several witnesses produced by the said *George W. Jones*, and considered their evidence and the other testimony adduced by him, they are of opinion that the party from whom a divorce is sought should have such specific information given to her as to the criminal intercourse with which she is charged as will enable her to prepare for her defence, and they are of opinion that the Petition and the preamble of the Bill referred to them, which embody all the information communicated to the respondent in this case, do not sufficiently set forth the circumstances upon which such a Divorce should be granted, particularly in not stating any place at, or even any period within which the alleged criminal intercourse took place, thus exposing the whole married life of the respondent to attack, and rendering it almost impossible for her to be prepared with exculpatory evidence.

And they humbly recommend that they be discharged from the further consideration of the Bill.

That an humble Address be presented to His Excellency the Governor General, praying that His Excellency will be pleased to cause to be laid before this House, copy of the Report on the Harbor of *Quebec*, made by *T. Trudeau*, Esq., Deputy of the Minister of Public Works, and Mr. *Ross*, together with the instructions given to these gentlemen in the course of last autumn, together with the Petitions and Memorials which led to the said Report.

The question of concurrence being put thereon, the same was resolved in the affirmative, and it was

Ordered, That such Members of the Privy Council as are Members of this House do wait upon His Excellency the Governor General with the said Address.

Pursuant to the Order of the Day, the Bill intituled: "An Act for the gradual enfranchisement of Indians, the better management of Indian affairs, and to extend the provisions of the Act 31st *Victoria*, Chap. 42," was, as amended, read a third time.

The question was put, whether this Bill as amended, shall pass ?

It was resolved in the affirmative,

Ordered, That the Clerk do go down to the House of Commons and acquaint that House that the Senate have passed this Bill with several amendments to which they desire their concurrence.

The Order of the Day being read, for the second reading of the Bill intituled: "An Act respecting contagious diseases affecting Animals."

On motion of the Honorable Mr. *Chapais*, seconded by the Honorable Mr. *Mitchell*, it was

Ordered, That the same be postponed until to-morrow.
