

Calgary on March 13 and the three following days, at which was passed a resolution urging the enactment of a measure providing that a workman's week shall consist of five days and not more than six hours' labour per day.

2. The Minister of Labour has received copies of various documents apparently emanating from what is termed "One Big Union" and favouring a general strike.

3. The Minister of Labour is following the matter closely and is advising with his colleagues as to action to be taken to meet any situation arising.

4. So far as the Department of Labour has learned, the principles and objects of "One Big Union" have not been yet determined. What is termed the "One Big Union" would appear to be yet in the formative stage only. The framework of a general organization does not yet exist. A central committee alone has been appointed with temporary officers. It is impossible therefore to state if the principles and objects of "One Big Union" are identical with those of the I.W.W.

5. A communication was addressed to Mr. Midgley as acting secretary of the Organization Committee of "One Big Union," requesting copies of the official reports of the proceedings at the Calgary gathering of March 13. Mr. Midgley replied promising to forward the copies as requested.
