CANADIAN PACIFIC AIR LINES—REQUEST THAT OVERHAUL WORK BE DONE IN CANADA

On the orders of the day:

Mr. D. M. Fisher (Port Arthur): I should like to ask the Acting Minister of Transport, whoever he might be, whether the attention of the department has been drawn to a report in last Friday's Winnipeg Free Press to the effect that Canadian Pacific Air Lines has carried out 85 per cent of its major overhaul work in foreign countries? If that is so, what steps could be taken to give Canadian Pacific Air Lines an incentive to do its overhaul work in Canada to provide employment for Canadians?

Mr. Boulanger: Mr. Chairman, I should like to make a few comments on item 658 of the estimates of the Minister of Agriculture. I intend to refer especially to the stabilization of farm prices.

Mr. Chairman, we are being asked to vote \$69,504,548 for the rest of the fiscal year ending March 31, 1961. During the discusion of the measure on agreements respecting the development of marginal lands, the Minister of Agriculture (Mr. Hamilton) stated, as reported on page 3264 of Hansard:

Then, there was the stabilization of prices, which is in effect now and the results of which are showing in the income figures.

Mr. Chairman, if we consider the situation which has prevailed these last years, we note that the stabilization of farm prices—

The Deputy Chairman: Order; I wonder whether or not the hon. member looked at vote No. 658, which is for the research branch. As a result of listening to the few remarks the hon. member has made, I have come to the conclusion he was not talking about research.

Shall vote No. 658 carry?

Mr. Herridge: Will the minister give us some explanation of this vote to the international botanical congress?

Mr. Fleming (Eglinton): Mr. Chairman, this item concerns a grant of \$10,000 toward the ninth international botanical congress. The congress was held and this further sum is required. The reason for the \$1 item is that there was sufficient money in the item to take care of the obligation but there was no authority to use the sum for the purpose of helping defray the cost of the botanical conference. The reason for the \$1 item before us is to give legislative effect to this vote.

Mr. Benidickson: This is the first item of the supplementary estimates to come before us. The Minister of Finance has been in this house for the same length of time as I have been, and he will recall that the previous government was criticized, particularly by the former hon. member for Winnipeg North Centre, to the effect that these dollar items should not be used without exceptional justification. He felt that they were designed to give parliamentary sanction to something about which parliament had no knowledge and perhaps no jurisdiction over the amount
