Question No. 283-Mr. Aiken:

- 1. Who was the successful candidate for the position of Director, Research and Planning, CRTC, advertised under Public Service Commission Bulletin No. 70-3601?
- 2. What are the qualifications and experience of the successful applicant as a Research Director?
- 3. What is the nationality of the successful applicant and is he completely bilingual?
- 4. (a) What salary or remuneration is paid to the successful applicant (b) does he receive, in addition, a per diem allowance and, if so, at what rate?
- 5. Where does the Director carry on his duties each day of the week?
- 6. How long has the successful applicant lived in Canada and what was his previous employment?
- 7. How many other persons applied for the position and were all such persons Canadians?

AUDITOR GENERAL

Question No. 306-Mr. Fortin:

Does the Auditor General audit the books of every (a) proprietary (b) mandatory (c) mixed economy Crown corporation and, if not, does the government intend, in the near future, to allow him to do so?

Hon. C. M. Drury (President of the Treasury Board): The Auditor General audits the accounts of all departmental and agency Crown corporations and all but five of the proprietary Crown corporations. Those five are: Air Canada; Canadian National Railways; Canadian National Railways Securities Trust; Cape Breton Development Corporation; Central Mortgage and Housing Corporation.

In addition, there are several other public instrumentalities for which the Auditor General is not the auditor. These are: Bank of Canada; Industrial Development Bank; Canadian Wheat Board.

As indicated in the Auditor General of Canada bill introduced the 16th of October, it is not proposed to alter the current legislative provision for the audit of Crown corporations, as found in sub-section 2 of Section 77 of the Financial Administration Act, which reads as follows:

77. (2) Notwithstanding any other Act, the Auditor General is eligible to be appointed the auditor or a joint auditor, of a Crown corporation.
