Such punishment has been abolished by Order-in-Council, number P.C. 1972-2327, dated September 21, 1972. Corporal punishment as a sentence awarded by a Court of Law has not been administered on any occasion during 1971. It has been abolished by the Amendment to the Criminal Code, Chapter 13, Section 59, given Royal Assent on June 15, 1972.
