BUSINESS OF THE HOUSE

MOTION TO LIMIT REPORT STAGE AND THIRD READING DEBATE ON BORROWING AUTHORITY BILL

Mr. Bussières moved:

That, in relation to Bill C-59, an Act to provide supplementary borrowing authority, one sitting day shall be allotted to the consideration of each of the report stage and the third reading stage of the bill; and that at 15 minutes before the expiry of the time provided for government business on those days, any proceedings before the House shall be interrupted, if required, for the purpose of this order and, in turn, every question then necessary in order to dispose of the stage of the bill then under consideration shall be put forthwith and successively, without further debate or amendment.

He said: Madam Speaker, all hon. members are fully cognizant of our Standing Orders and even if at times we do forget the exact wording, we know that when we study certain bills we can proceed with dispatch under the provisions of Standing Order 75. For instance, it is possible for the leaders of the various parties in the House to reach agreement and allocate a given period of time to complete the study of a bill. When the parliamentary leaders are unanimous, they so advise the House and we agree on the way to end the debate. We do have another procedure when there can be no agreement on the amount of time to be devoted to debating a bill. When we cannot agree a notice must be given to hon. members in which the government states its intention of setting a time limit to study a bill. That notice was tabled last week and this evening I am indeed proposing that one additional day be devoted to the report stage of the bill to provide supplementary borrowing authority, and one additional day as well for third reading of the same bill.
