LIKELIHOOD OF DISRUPTION IN MAIL SERVICE

Mr. John Bosley (Don Valley West): Madam Speaker, I have a question for the Postmaster General, who we thought would be in the House. In his absence, perhaps I could put it to the Minister of Labour, who I gather is a party in the conversations.

Now that the conciliation board report is public and CUPW has indicated that it regards that report as a basis for avoiding a strike, can the minister and the government assure the House that we can expect no mail disruption this spring?

Hon. Gerald Regan (Minister of Labour): Madam Speaker, I thank the hon. member for his question. I wish, indeed, that it were possible in the case of unresolved labour disputes to always give an absolute assurance that there would be no disruption. Unfortunately, that cannot be done until negotiations are completed and an agreement achieved.

I can say that the Postmaster General has indicated that he is optimistic about the possibility of a settlement, and that he is hoping to meet, along with certain officials, representatives of the union this afternoon for discussions arising out of the conciliation board report. It is expected that the Postmaster General will be in the House tomorrow and in a position to answer queries in relation to today's meeting to the extent that it is possible to comment without endangering the ongoing negotiations.

Mr. Bosley: Madam Speaker, arising out of that answer, since the minister was present at the conversations yesterday, perhaps he could advise what position the government is taking in today's meeting, specifically since there has been at least a publicly reported suggestion that the Minister of Labour is contemplating back-to-work legislation. Can the minister advise whether the government has decided to accept the conciliation board report or to fight it?
