disabled veterans, the amount of the basic rate of the disability pension, and the need for some increase in the war veterans allowance, particularly for veterans who are below the age of 65.

Will the President of the Privy Council, with the weight and the clout of his position, get on the side of the Minister of Veterans Affairs in cabinet in an effort to get this legislation before the House very soon? Veterans just do not understand why they have to wait so long for this urgent legislation. I hope he is now in a position to tell us that it will be in the House in time for us to pass it before any summer recess.

Mr. Pinard: Madam Speaker, it all depends on when there will be a summer recess, if any. I agree with the hon. member that the subjects he just talked about are very important and are priorities on this side. I witnessed his questions to the hon. minister during the week, and I can assure him that those subject matters are under consideration.

As far as the legislation itself is concerned, surely the hon. member will know that there are many items on the order paper which must be dealt with before the summer recess. I hope we are in a position, with the collaboration and good will of both sides of the House, to get through the backlog and at the same time deal with the very important issues raised by the hon. member for Winnipeg North Centre.

Mr. Knowles: Madam Speaker, as a supplementary question, may I ask something of the minister. I do so because I would not want my suggestion that this should be done before the summer recess to end in nothing because there is no summer recess. We will work that out. I hope something can be done this month with a view to its being passed certainly before the end of July.

While the government is considering this matter, may I point out that certain legislation before the House last December had an effective date of April 1, 1980. I hope the government will consider making any legislation for veterans retroactive to that date.

Mr. Pinard: I will take the remarks of my hon. colleague under serious consideration.
