7. The Minister has acted according to one of the mandates of the Department which is to promote healthy lifestyles for Canadians and to enhance the program objectives of the "Generation of Non-Smokers".

Hon. André Ouellet (Minister of Consumer and Corporate Affairs): Madam Speaker, I now rise to speak to the motion which is before the House and to remind Hon. Members—

Miss MacDonald: I rise on a point of order.

Mr. Deputy Speaker: The Hon. Member for Kingston and the Islands rises on a point of order?

Miss MacDonald: Yes, Mr. Speaker. I do not mean to interrupt or delay the Minister, but when we broke at one o'clock p.m., I was in the middle of answering questions of the—

Mr. Deputy Speaker: My understanding was that there was no one rising to ask further questions at that point.

Miss MacDonald: On the same point of order, Mr. Speaker, I was in the middle of answering a question from the Hon. Member for Gatineau (Mr. Cousineau), who had asked me whether or not I had used the figure of 2.5 million people on Unemployment Insurance and whether that was correct. I undertook to check the blues and, in fact, found that I had

**Mr. Ouellet:** Mr. Speaker, I think it was clear that the ten minutes allowed for questions had elapsed and that it was time to proceed with the debate and recognize the next speaker.

I am pleased with this opportunity to remind the House that it is the second time in four weeks that the Opposition is spending a full day of Parliament's time on the subject of conflict of interest. I thought the Leader of the Opposition, the Hon. Member for Yukon (Mr. Nielsen) and the Hon. Member for Kingston and the Islands (Miss MacDonald) would have used this second day of debate to bring forward new elements and to present evidence in support of the as yet unwarranted allegations and accusations they made repeatedly in their speeches and comments, both today and a few weeks ago, when a full day was spent on the same subject. I think it is most unfortunate that Members on the other side of the House, and especially Progressive Conservative Members, should be raising a storm about the so-called Coalgate scandal.

Mr. Speaker, as far as I am concerned, using this expression the Progressive Conservative have tried to instil an element of mistrust in public opinion, and this attempt to discredit not only politicians but former politicians is truly reprehensible, because in fact, there is not a shred of evidence that Mr. Gillespie was given preferential treatment in this matter.
