and surrounding areas a petition protesting the downsizing or closure of the CN shops in Moncton. Twelve hundred jobs are being threatened and already 225 lay-off notices have been sent to the workers. They ask the Government to try and stop that very depressing situation.

FULL INDEXATION OF FAMILY ALLOWANCE AND REPEAL OF TAX INCREASES

Mr. Ian Waddell (Vancouver-Kingsway): Mr. Speaker, I have a number of petitions from various communities in British Columbia. Unlike some Conservative Members, including one Minister, from British Columbia, I am going to read them out instead of tabling them secretly with the Clerk.

Mr. Speaker: Order, please. Will the Hon. Member just do that as opposed to giving us a preamble?

Mr. Waddell: No more preambles, Mr. Speaker. I have petitions from Gibson's Landing, Maple Ridge in the Fraser Valley, and Vancouver, including my riding of Vancouver-Kingsway. Numerous people have protested this Bill and they call upon the House of Commons to reinstate full indexation of universal family allowances and rescind unfair tax increases.

Mr. Stan J. Hovdebo (Prince Albert): Mr. Speaker, it is my duty and honour to present a series of petitions from Halifax and Dartmouth, Nova Scotia. I have another series of petitions from Vancouver and Burnaby, British Columbia. The petitioners call upon the House of Commons to reinstate full indexation of universal family allowances and rescind unfair tax increases.
