

EXHIBITION LIVE STOCK

IS BIG FEATURE OF WEEK

Record of Awards Saturday and Many Interesting Events for Monday.

The live stock industry was the centre of a considerable gathering during the day. This feature of the big show is growing in importance daily. In point of capital represented, it exceeds any other division of the Exhibition. The cattle, horses, swine, sheep and poultry exhibits are now complete, and fanners from many parts of the Dominion are present. Purchasers of blooded stock are on the grounds, and many of the animals are being bid up in a very animated manner.

J. W. Coulter, the well-known horse fancier and breeder of blooded animals, observed to The World that he had been exhibiting on the Exhibition grounds for 35 years, and he never saw the live stock display looking so magnificent as this season. He is enthusiastic over the display.

The judging of cattle, bacon hogs, sheep and the horses continued during the day, arousing much attention. The showmen will have the final Monday. This competition promises to be most exciting, and the entries aggregate 240.

The parade of horses in the morning afforded a good view of the value of the exhibit of blooded animals from all parts of the Dominion.

Butter-Making Awards.—The butter-making contest was finished at noon. Monday and Tuesday the dairy work will be most entertaining, the contests being open to the families of farmers throughout Canada.

The awards in the butter-making competition were made on Saturday afternoon. In the professional class the winners were: Miss Mary L. Green, 1; Miss M. Hunter, 2; Miss H. McAllister, 3; Miss K. M.
