### PAROCHIAL CONSTITUTION.

1. This Association shall be called, "The Branch of Woman's Auxiliary to the Domestic and Foreign Missionary Society of the Church of England in Canada.
2. The objects of this Branch shall be : To pray for missions ; to aid the Woman's Auxiliary in its work of interesting church women in missionary work by one common bond of harmonized effort ; to diffuse missionary intelligence and to infuse missionary zeal amongst the children of the Church ; to receive contributions towards the funds of the Domestic and Foreign Missionary Society
3. All women who desire to be members of this association may become such by the payment of an annual subscription (from ten cents to \$1.00), which fees shall be at the disposal of the Parochial Branch
4. The Board of Management shall consist of a President, a Vice-President, a Recording Secretary, a Corresponding Secretary and a Treasurer, together with two women nominated by the Rector of the Parish.
5. The Annual Meeting shall be held in April.
6. The Order of business at the Meetings shall be :—
  1. Prayer ; 2. Minutes of the last meeting ; 3. Correspondence ; 4. Treasurer's Report ; 5. Offerings, (if so arranged) ; 6. Missionary intelligence and Miscellaneous Business.
7. Special meetings may be called by the President at the request of two-thirds of the Board.
8. This constitution may be amended by a two-thirds vote at the Annual Meeting, notice in writing having been given at a previous meeting.

1. The President, or her substitute, shall preside at the Meetings.
2. The duty of the Secretary shall be to give notice of all meetings, to prepare and read a monthly Statement of the work of the Branch, and to send to the Diocesan Auxiliary, a copy of the Annual Meeting.
3. The corresponding Secretary shall be responsible for the correspondence of the Society, and to forward to the Treasurer all money and articles contributed, and to present a monthly Report to be presented to the Diocesan Auxiliary.
4. The Treasurer shall be responsible for the money and articles contributed, and to present a monthly Report to be presented to the Diocesan Auxiliary.
5. The board shall be responsible for the missionary spirit ; shall augment the funds of the Society, and shall visit the several branches of the Society, enrolling new members and subscriptions.
6. In the interest of the Society, the Board should elect a lady, residing in the parish, to represent the Branch and to visit the City Parochial Branch.
7. This lady may be chosen by the Board. She would be expected to attend the meetings or to obtain a list of names to advise her Branch of the names of those prepared to give expressions of interest. (See final clause paragraph)
