LOSS OF THE SS. ERIN.  
No Tiltling of Her Feet—The Worst Storm in Years.  
New York, Jan. 22.—The National Line steamer Erin, which is feared has been lost at sea, carried no passengers. She had a crew of sixty or seventy men, and about fifteen cattlemen were on board. The Erin had a deckload of cattle in pens and a general cargo, including cotton, below decks. She was one of the swiftest and staunchest of the older vessels of the National Line. F. W. J. Hurst, the line's agent here, said last night that he believed the Erin was afloat, but had probably broken down.  
The weather on the North Atlantic this winter has been very boisterous. The hydrographic office cannot recall anything like it, and the ship carpenter unanimously pronounces it the worst they have ever experienced. A series of awful westerly gales has been howling off the banks of Newfoundland for the last five weeks.  
London, Jan. 22.—The steamer Erin has now been out twenty-five days, and there is hardly any doubt in maritime circles that some disaster has befallen her. The fears concerning her safety have been greatly augmented by a report made by the British steamer Creole (Capt. Darling) at Bremen, from New Orleans, which on January 9 saw a steamer's lifeboat adrift bearing the name of the Erin. The finding of the boat alongside and took from it ten ash oars and a mast and sail. A lifeboat, a steamer's bridge, and an awning were also seen floating near the lifeboat.
