

By Mr. Pouliot:—Order of the House for a Return showing:—

1. Since August 1, 1930, whether the Post Office Department awarded contracts without first calling for tenders.
2. If so, the names and addresses of the contractors.
3. The date and the amount of each contract.
4. For what purpose each contract was awarded.

By Mr. Munn:—Order of the House for a Return showing:—

1. What amounts were paid by the Dominion Government in each of the years 1929, 1930, 1931, 1932, and 1933, for rentals, office space, storage, and other purposes, in the City of Vancouver, British Columbia.
2. To whom this money was paid, where each property is located, and for what purpose was each such property used.

The following Addresses were voted to His Excellency the Governor General, and Orders of the House issued to the proper officers:—

By Mr. Vallance:—Order of the House for a return in tabulated form showing the amounts expended monthly for material and supplies for unemployment relief in Prince Albert National Park, from the inception of the camps to date.

By Mr. Vallance:—Order of the House for a return in tabulated form showing the amount expended per month on unemployment relief in Prince Albert National Park, together with the number of men employed during each month, from the inception of the camps to date.

By Mr. Vallance:—Order of the House for a copy of pay lists showing the moneys expended in wages or salaries to foremen, superintendents, inspectors and subforemen, in connection with unemployment relief in Prince Albert National Park. Such lists to indicate amounts paid monthly from the time the camps were established in the said park to date.

By Mr. Vallance:—Address to His Excellency the Governor General, for a copy of Order in Council, if any, dealing with unemployment relief of permanent park residents in Prince Albert National Park.

By Mr. Vallance:—Address to His Excellency the Governor General, for a copy of Order in Council P.C. 2358, 1932, and P.C. 52, 1933, and any other Orders in Council, in connection with unemployment relief of single homeless men in Prince Albert National Park.

By Mr. Casgrain, for Mr. Ralston:—Order of the House for 1. A statement giving the following particulars respecting reviews made during 1933 of dependents' pensions, separating the information as respects reviews made, from January 1, 1933, to September 30, 1933, and from October 1, 1933, to December 31, 1933, showing (a) the number of files reviewed; (b) at whose instance reviewed, i.e., Board of Pension Commissioners or Canadian Pensions Commission, Auditor General, Department of Pensions and National Health; (c) number of pensions reduced; (d) total yearly amount of reduction; (e) number of pensions cancelled; (f) total yearly amount of cancelled pensions; (g) number of cases in which suspension or partial suspension, withdrawal or reduction, has been made in order to recover an alleged overpayment of pension on the ground of alleged invalidity of marriage or absence of proof of marriage; (h) total yearly amount of such suspensions or partial suspension, withdrawals or reductions;

2. A statement giving similar information regarding disability pensions;
