CANADIAN FLAG-RECOMMENDATIONS OF PARLIAMENTARY COMMITTEE

Question No. 60-Mr. Hansell:

2. If so, have steps been taken by the government to bring down legislation implementing the committee's recommendations?

With reference to section 61 of the Auditor

General's report, 1957:

1. What is the name of the firm which received the \$119,200 contract to build a naval vessel for the Department of Defence Production?

2. Were tenders called for this contract through

advertising?

3. What officers of the department signed the progress certificate under which the contractor was paid for work?

4. What was the total amount paid to the con-

tractor under this contract?

5. Was the contract finally cancelled?

6. If so, what percentage of the work was completed at time of cancellation?

7. What is being done with the incompleted

Hon. Howard C. Green (Minister of Public Works): Mr. Speaker, there are seven parts to this question, the answers to which are as follows:

- 1. Withey's Shipyard Limited, Silva Bay, Gabriola island, B.C.
- 2. The original requirement, of which this vessel is a part, covered seven harbour craft and four clearance diving vessels. Tenders were invited on the total requirement on August 7, 1951. After examination of the tenders it appeared that the specifications for the clearance diving vessels were less than adequate. Accordingly on October 1, 1951, tenders were recalled for the seven harbour craft only, and contracts subsequently awarded for such vessels.

The specifications for the clearance diving vessels were rewritten. Rather than recalling tenders the clearance diving vessels were allocated, such allocation being made on the recommendation of the Canadian maritime commission and limited to those companies
