WINTER WORKS-EXTENSION OF PROGRAM IN PICNIC AREAS

Hon. W. G. BARLEY-ANNOUNCEMENT OF FINAL PAYMENT

Hon. Alvin Hamilton (Minister of Agriculture): Hon. members will recall that on February 13 last I announced the final payment on the 1959-60 oat account. I am now pleased to be in a position to announce final payments on the 1959-60 barley account.

The 1959-60 barley pool was closed as at March 30, 1961. Producers delivered 94.9 million bushels of barley to the pool and the surplus for distribution to producers is \$2,022,170.66. The final payments for distribution to producers on the principal grades of barley are as follows:
