Questions

- 4. The sharing of the cost is a matter for agreement by the governments of Canada, Ontario and Quebec.
- 5. Correspondence is being carried on with the provinces and discussions are being held with the city of Ottawa.

GRAZING AND HAY PERMITS, RIDING MOUNTAIN PARK

Question No. 365-Mr. Mandziuk:

- 1. How many grazing permits were issued in the Riding Mountain national park in 1965 and what were the fees charged?
- 2. How many hay permits were issued for the Riding Mountain national park in 1965 and what were the fees charged?
- 3. What grazing permit fees and hay cutting fees will be charged in 1966.

Hon. Arthur Laing (Minister of Northern Affairs and National Resources): 1. Fifty five grazing permits were issued. The following fees were charged: (a) For grazing permit, \$1 (b) For each head of cattle, 25 cents per month; (c) For each horse not owned by a licensed livery operating in the park, 50 cents per month.

- 2. Forty one hay permits were issued. The following fees were charged: (a) For hay permit, \$1; (b) \$2.50 per ton.
- 3. The existing rates are currently under review and a decision will be announced well in advance of the 1966 grazing and haying season.

TENDERS FOR COAST GUARD VESSELS

Question No. 372-Mr. MacEwan:

- 1. When will tenders be called for the construciton of four new coast guard vessels?
- 2. Will the tenders be called on a nation-wide basis or regional basis?

*BAIT-HERRING FISHERY, SAANICH INLET, B.C.

Question No. 375-Mr. Groos:
