LABOUR CONDITIONS

MEASURES TO PROVIDE EMPLOYMENT OPPORTUNITIES—RECRUITING OF STUDENTS

Hon. Robert L. Stanfield (Leader of the Opposition): Mr. Speaker, I should like to direct a question to the Minister of Finance concerning the decline in employment opportunities, especially in certain parts of the country and in particular, perhaps, in connection with the reduction of recruiting activity on campuses and the decreasing prospect of students securing either temporary or permanent employment. Mr. H. Russell MacEwan (Central Nova): May I ask the minister—and this applies to all his cabinet colleagues-whether, when studying this matter, they would consider introducing a crash program to alleviate the heavy unemployment in the Atlantic provinces now running, I believe, at 10.1 per cent?

Mr. Benson: We always take very seriously suggestions by the hon. member.

Mr. Lloyd R. Crouse (South Shore): In this regard, would the minister consider, too, reintroducing the federal shipbuilding subsidy which would be a great help in making employment opportunities available in the Atlantic shipyards used especially for the restoration of our fishing fleet on the east coast?
