In view of the report of le Centre de Planning Familial du Québec to the effect that during the past 12 months there have been an estimated 10,000 to 25,000 illegal abortions in that province compared with 181 legal abortions, when does he intend to change the law to permit women to obtain legal instead of illegal abortions?

Mr. Speaker: Order, please. I have the impression this question has been asked on a number of occasions. If the minister feels he has anything to add to his earlier answers he might be allowed to reply now.

Hon. John N. Turner (Minister of Justice): I have nothing to add, Mr. Speaker, except to say I cannot accept the preamble to the report, which I have not read, but because of the insistence of the hon. lady I will read the report.
