Right Hon. P. E. Trudeau (Prime Minister): Mr. Speaker, there is no intention to prevent the many sports in which I participate in Canada from being played in Canada. The purpose of this bill, if the hon. member wants to read the 18 speeches made by the opposition, is completely different from the one he suggests.

Mr. MacInnis (Cape Breton-East Richmond): Mr. Speaker, apparently the Prime Minister completely misunderstood my question. In that the Prime Minister is a patron of rugby football in Canada, will he look at the definition provided in the bill which excludes that particular sport; and why is he acting as a patron of rugby football while he allows one of his ministers to deny it what is its rightful place? I point out that the Grey Cup is inscribed "for amateur rugby football" in Canada.

Mr. Trudeau: Mr. Speaker, I may have misunderstood the question, but I suggest that the hon. member misunderstands the bill. It is not intended to prevent any sport flourishing in Canada. On the contrary, it is to help the flourishing of sport in Canada.

Mr. Speaker: Order, please. Is the hon. member rising on a question of privilege?

Mr. MacInnis (Cape Breton-East Richmond): Yes, Mr. Speaker.

Mr. Speaker: May we have order, please. I remind hon members that we will be running short of time very soon. The hon, member has the floor.

Mr. MacInnis (Cape Breton-East Richmond): When I get order, I will speak, Mr. Speaker. The Prime Minister has indicated that probably I do not understand the bill. If he would refer to the definitions in the bill he would find out that rugby and soccer have been excluded, thereby denying to amateur sports in this country what is rightfully theirs. I am not the one who misunderstands the bill; it is the Prime Minister who does not know what it is all about.

Hon. Daniel J. MacDonald (Minister of Veterans Affairs): Mr. Speaker, I have discussed this question with the Burnaby authorities and they are well aware that I have this responsibility. I spoke to them recently and they know what the process will be.

Mr. Leggatt: My supplementary question is exactly the same as my first question, because I did not get an answer to my first question. Would the minister indicate whether he will now enter into negotiations with the municipality of Burnaby? Will he give that assurance to the House?

Mr. MacDonald (Cardigan): Negotiations will be entered into at the appropriate time.

Hon. Jean Chrétien (Minister of Indian Affairs and Northern Development): Mr. Speaker, I am glad to say to the hon. member that I have contacted the Minister of Labour, who is always very diligent, and I can say that the parties will be meeting on Friday, at which time I hope the difficulty will be resolved. I thank the Minister of Labour for his good work.
