Oral Questions

MEASURES TO OVERCOME SHORTAGE OF FEED GRAIN IN QUEBEC

Mr. Léonel Beaudoin (Richmond): Mr. Speaker, I should like to put a question to the Minister of Agriculture.

Since for about a month Quebec co-operatives and farmers are unable to obtain feed grain, especially wheat and oats, because the Montreal warehouses are empty, can he tell us whether he is aware of such conditions and if so whether the department intends to act to improve the situation which I find most difficult for producers?

Hon. E. F. Whelan (Minister of Agriculture): Mr. Speaker, we have been talking with these people who are using grain and I have no evidence at all of any producer who has gone without grain. If any member of the House has any evidence of producers who have gone without grain he should bring that to my attention by being more specific. We also have the upgrading of rail shipments of grain to eastern Canada, and the Wheat Board will be responsible for any extra increase in the cost that may be involved.

NORTHERN ALBERTA—REQUEST FOR ASSISTANCE TO FARMERS WHO SUFFERED CROP LOSSES BECAUSE OF EARLY SNOWFALL

In view of the fact that advance interest free payments on grain under the snow are being made, in addition to further consideration we are giving in respect of aid in transportation, etc., and the program the province of Alberta has initiated itself, although that has not been finalized at the present time, we hope to be able to work out an agreement with them very shortly.
